- The method of payment will be cash or **bank to bank transaction** thru **Metrobank**. Account details will be provided upon request. Send a copy of deposit slip through email immediately upon payment to the bank.
- The PRC BAC will hold a **pre-bidding conference** on **12 April 2024**, 10:00am at the PRC Tower, 9f Big Meeting Room. A site inspection will be held after the conference.
- Bids and eligibility requirements must be delivered to the address below on or before **19 April 2024, 11:00am**. All Bids must be accompanied by a **Security Bid** in the form indicated in the bid documents. Late Bids shall not be accepted.
- All bidders interested in participating should undergo the PRC accreditation process by submitting the necessary documents and fees as required by the PRC. No bidders are allowed to participate unless accredited. Attached are the accreditation form and requirements.
- The PRC reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids any time prior to contract award, without incurring any liability to the affected bidder/s. It likewise assumes no responsibility whatsoever to compensate or indemnify the prospective bidders for any expenses incurred in the processing of their eligibility to bid and/or in preparation of the bid.
